

Financial Highlights

- Offertory collections were \$22,000 or 1% *lower* than last year primarily due to one less Sunday in the current period. On a normalized basis, offertory is estimated to be flat compared to last year. Registered households grew to 11,112 or by 2%, indicating the average contribution per household has declined by 3%.
- Total 2020 financial commitments to offertory through our stewardship of treasure effort have increased 30%.
- Operating expenses were \$15,000 lower than last year, primarily due to a lower facilities expense and timing of charity payments, partially offset by lower than anticipated escrow rebate from the MACS tuition. Operating expenses were \$138,000 or 3% below budget. The parish intends to meet its charity budget by June 30.
- RENEW donations helped fund a new sanctuary sound system, a camera system to live stream Mass to the banquet room, and exterior signage.



Diocesan Support Appeal ("DSA") and Priests' Retirement Assessment

- After exceeding our 2018 DSA goal, St. Matthew narrowly missed the 2019 goal by just \$1,000. However, both the goal and contributions were lower in 2019 compared to 2018. 2019 contributions of \$836,000 were \$48,000 lower than the prior year. Surpluses from the DSA are reserved to help fund a Habitat House.
- Additionally, for over ten years, we have not met our Priests' Retirement assessment from the Diocese. Although contributions were \$10,000 higher than in 2018, they were \$122,000 lower than our goal. Again, this is a mandated assessment by the Diocese, and any shortfall must be made up from our parish operating funds.

What We All Can Do

- Average offertory per household is currently lower than last year. Consider increasing your offertory giving to ensure the funding of our exciting spiritual and youth oriented goals of our new pastoral plan.
